



- **Historic information collected in January 2009**
- **Site reconnaissance in January**
- **Take soil, water, and waste samples**
- **Location of JATO tubes in water**





Archaeological Sites

- Memorandum of Agreement (MOA)
 - Puerto Rico State Historic Preservation Officer (SHPO)
 - Concurrence: Portal del Futuro and PR Dept of Natural and Environmental Resources
- How any potential adverse effects will be mitigated
- Archaeological data recovery efforts
- Artifacts housed in an archaeological curation facility that meets the standards outlined in regulations (36CFR79)
 - *“recognized that at the time of this MOA ... there is no federally approved archaeological repository located in the Commonwealth of Puerto Rico that is prepared to accept this collection.”*
- Copy of Archeological Report will be provided to RAB
