HPS Site Tour for the Community on April 26, 2008



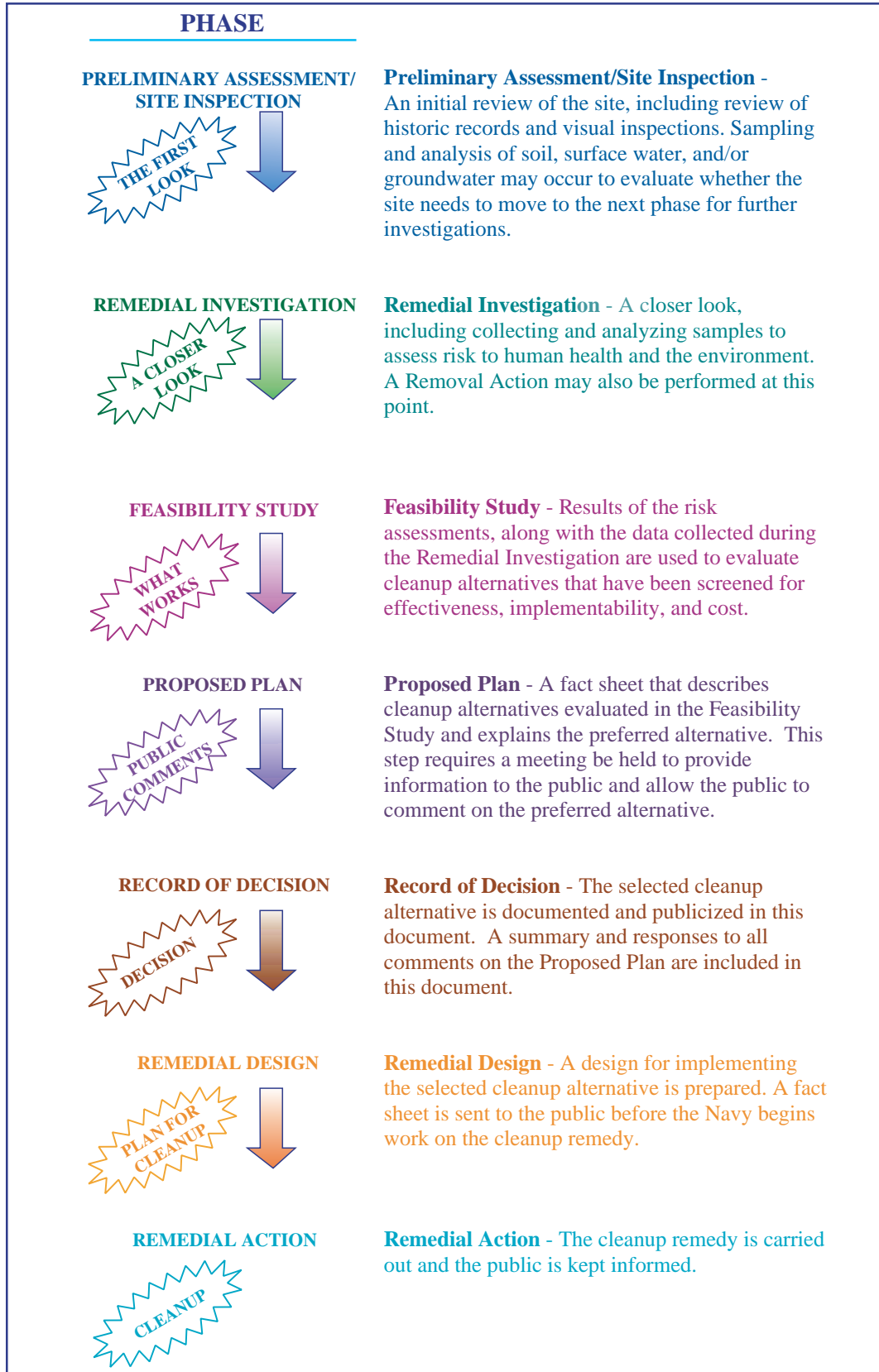
HPS RAB Peoples Earth Day Booth on April 26, 2008
