PREPARING FOR TOMORROW

Overview

The Navy's Community Involvement Plan (CIP) for Hunters Point Naval Shipyard (HPNS) lists several ways for the HPNS cleanup team to reach out to the HPNS community, including quarterly summaries of community involvement achievements and goals for the coming months. This update summarizes the HPNS public involvement activities held between January and March 2016, as well as upcoming activities and documents scheduled for April through June 2016.

PROGRAM OUTREACH ACHIEVEMENTS: JANUARY-MARCH 2016

Community Survey

During the month of January 2016, the Navy conducted a survey to gather information on community concerns about the cleanup at HPNS, evaluate recent community outreach methods, and determine the best way to communicate with members of the HPNS community.

The survey was mailed to almost 12,000 residents and businesses and emailed to all 833 addresses on the HPNS distribution list. Fliers were mailed to 37 community groups for distribution and posting and a survey link was posted on both Navy and regulatory agency websites.

The data gathered during the 2016 survey will help guide the Navy in future outreach activities within the HPNS community. The Draft CIP will be available for public review later this year.

Survey Participation

105 people participated in the January 2016 survey.

◆ Participation by ZIP Code:

- * 94124 - 41%
- * 94107 - 26%
- * 94134 - 23%

◆ 31% of participants reported involvement in one of 45 community and/or environmental groups

- ◆ 42% requested to be added to the HPNS mailing list and 44% advised that they were already on the mailing list

Concerns about Cleanup at HPNS

The top 5 most frequently reported concerns about the cleanup at HPNS included:

1. Current schedule for environmental cleanup
2. Health concerns associated with cleanup
3. Completeness and honesty/transparency of cleanup
4. Effectiveness of cleanup
5. Types of contaminants being cleaned up

Communication Methods and Interests in Information about the Cleanup at HPNS

The majority of participants requested that cleanup information be provided electronically on a quarterly basis, or as necessary with program developments. The top 5 most frequently requested topics for information included:

1. General information on environmental cleanup at HPNS
2. Current schedule for environmental cleanup
3. Information on the City of San Francisco's Redevelopment Plan
4. Health concerns associated with cleanup
5. Historical information about HPNS

NAVY BASE REALIGNMENT AND CLOSURE (BRAC)



In 1988, the Department of Defense created the Base Realignment and Closure (BRAC) Program to oversee the cleanup and transfer of military bases to public or private groups for redevelopment.

HPNS was added to the BRAC Program in 1988, and the Navy has been working since that time to clean up hazardous wastes created by former shipyard use.
